Rainbows End Cabins at Mt. Rainier welcomes your stay at one of our vacation cabins! Mountain Peek, Squirrel Run, Nisqually Chalet, Serenity Cabin, or Spike Camp luxury cabins. We have done everything possible to make your vacation a memorable occasion. We have a few basic rules that we sincerely hope will not inconvenience you in any way. We do welcome “feedback” about your stay, so please make a note for us in your cabin’s notebook.

1. As you will notice, Rainbow’s End Cabins at Mt. Rainier, takes great pride in the cleanliness of our cabins. We provide clean linens, kitchen ware, toilet amenities, propane gas for the BBQ, fire wood, and maintenance of the hot tub and premises. We expect you to leave your cabin in a clean, neat condition. We will dispose of trash and thoroughly clean after each rental, at no charge. If we find we have extra work washing pots, pans, dishes, BBQ etc. we will add an additional \$50.00 cleaning fee to your bill, after a consultation with you.
2. The Management has the right to evict guests from our cabin properties if rules are broken. The guest will forfeit any payments and deposits as a result of said eviction.
3. Cancellations within 30 days of reserved dates are subject to a 10% cancellation fee. If the cancellation is within 15 days of reserved dates there will be a 50% cancellation fee unless we rent the cabin for your dates which would result in a 10% cancellation fee.
4. Rainbows End Cabins at Mt. Rainier, hereafter referred to as Management, are NON-SMOKING establishments. If there is evidence, smell, of smoking, there is an automatic \$200.00 fee to rid the smoke/smell from the building.
5. Management charges a \$25.00 mailing fee plus shipping costs to return items left behind by the occupants. We will hold any left items and contact you to get your permission and payment before returning said items.
6. Management is not responsible for accidents or injuries to renters, pets, or their guests. Renters assume ALL LIABILITIES for the well being of themselves, their pet(s), and visiting guests, and will not hold Rainbows End Cabins at Mt. Rainier or the cabin owners liable.
7. Visiting guests are not allowed to spend the night. A \$15.00 per person per night fee will be charged if they do.
8. Management is not responsible for any lost or stolen property.
9. Management allows up to 2 dogs at any of the pet friendly properties.
10. Children 10 years of age or older are allowed at any of our cabins. (Exceptions to this rule must be previously arranged with The Management.) All children under 18 years of age must be in the accompaniment of an adult at all times.
11. There is an automatic \$175.00 damage/security deposit required of each cabin rental. In the event of damage, management is authorized to charge cardholder the minimum of \$175.00 for damages to cabin. Management has authority to bill tenant /cardholder for remaining balance for damages due and/or to seek legal action against tenant/cardholder to recover loss for damages caused by tenant/cardholder while staying at any of the cabins.
